

## SEVERE WEATHER PREPAREDNESS WEEK MARCH 3-9, 2024

WHEREAS, North Carolina is traditionally an active area for tornados and severe thunderstorms; and

WHEREAS, in 2023 North Carolina experienced 24 tornado touchdowns and the National Weather Service (NWS) in North Carolina issued 51 tornado warnings; and

WHEREAS, last year the National Weather Service in North Carolina issued 751 severe thunderstorm warnings and recorded 127 large hail events and 844 damaging thunderstorm wind events; and

WHEREAS, the average warning lead time for tornadoes was 6-11 minutes and 57 minutes for flash floods; and

*WHEREAS, severe thunderstorms produce hail at least an inch in diameter, 58 mph+ winds or can produce a tornado; and* 

WHEREAS, all thunderstorms produce lightning and strikes are a significant threat in North Carolina. Remember, if you hear thunder roar, go indoors!

WHEREAS, Cumberland County residents should listen to local radio, television, a weather channel or a National Oceanic and Atmospheric Administration (NOAA) weather radio for information on severe weather; and

WHEREAS, residents should make a family emergency plan with details on how to get to a safe location, contact each other and get back together. Include in the plan the safest locations on their regularly traveled routes; and

WHEREAS, residents should have an emergency supply kit in their homes and vehicles that include a first aid kit, battery-powered radio, flashlight and non-perishable foods, bottled water, sturdy shoes and gloves; and

WHEREAS, Cumberland County residents, businesses and schools are urged to participate in the statewide tornado drill on Wednesday, March  $6^{th}$  at 9:30 a.m.; and

WHEREAS, Cumberland County Emergency Management works to inform and educate residents about staying safe when severe weather strikes and ReadyNC.gov is available to provide current weather and traffic conditions; and NOW, THEREFORE, We, the Cumberland County Board of Commissioners, hereby proclaim March 3-9, 2024, as "SEVERE WEATHER PREPAREDNESS WEEK" in Cumberland County, and call upon our residents to observe the week with appropriate activities that promote awareness of severe weather and how to stay safe.



## **BACKGROUND**

North Carolina General Statute Chapter 159, Article 3, entitled "The Local Government Budget and Fiscal Control Act", authorizes the Governing Board to appoint Deputy Finance Officers to designated individual(s) who possess the requisite knowledge, experience, and qualifications to serve in the Deputy Finance Officer role and to fix the amount of the faithful performance bond to be provided by the appointee. This is done to ensure continuity of operations in the absence or unavailability of the Finance Officer. There have historically been two finance staff who have served in this role. One of the appointees, Ivonne Mendez, left County employment effective Feb. 9, 2024. I recommend that Elizabeth Cherry, Finance Accountant, be appointed as a Deputy Finance Officer for Cumberland County.

**WHEREAS,** North Carolina General Statute Chapter 159, Article 3, entitled "The Local Government Budget and Fiscal Control Act", authorizes the Governing Board to appoint Deputy Finance Officers to designated individual(s) who possess the requisite knowledge, experience and qualifications to serve in the Deputy Finance Officer role and to fix the amount of the faithful performance bond to be provided by the appointee.

**NOW THEREFORE**, to facilitate the operational requirements of the Cumberland County Finance Department, the Board of County Commissioners herby RESOLVES that:

- 1. Elizabeth Cherry is appointed a Deputy Finance Officer and is authorized to receive and deposit funds, execute signature cards for the existing county's official depositories, approve purchase orders, maintain accounting records, preaudit certification on obligations and disburse funds for Cumberland County.
- 2. The appointee will provide a faithful performance bond in the amount of \$50,000.



## **BACKGROUND**

The Cumberland County Board of Commissioners approved the FY 2023-2024 Juvenile Crime Prevention Council (JCPC) funding recommendations at their June 5, 2023, meeting. The North Carolina Division of Adult Correction and Juvenile Justice (DACJJ) Office approved funding of \$1,119,291 for the Cumberland County Juvenile Crime Prevention Council (JCPC) to award to county youth-focused programs. JCPC approved and awarded nine youth-focused programs (including administrative funding) to receive funding for FY2023-2024.

The FY 2023-2024 funding included a funding award to the Pickens Peace Project for \$81,763. During the second quarter of FY 2023-2024, JCPC received notice from the DACJJ office to cease funding to the Pickens Peace Project due to non-compliance with maintaining their Internal Revenue Service 501c3 nonprofit status and, therefore, was not eligible to receive any additional funding. At the February 14, 2024, meeting, JCPC voted to reallocate the remaining contract amount of \$69,446 of the Pickens Peace Project to currently funded programs per the request of the JCPC Finance Committee. JCPC approved the following reallocated funding recommendations for the Board of Commissioners' approval at the March 4, 2024 meeting:

## SUBJECT: CONSIDERATION OF FINAL APPROVAL OF THE SALE AND EXCHANGE OF CERTAIN PROPERTY IN THE CUMBERLAND INDUSTRIAL CENTER

## **BACKGROUND**

The attached **Exhibit A** shows the lots adjoining Research Drive in the Cumberland Industrial Center. The property with the address number of 4801 is the location of Fayetteville Steel, which is owned by a limited liability company in which Michael O'Hern is the principal. The property with the address number of 500 is owned by Mr. O'Hern. Mr. O'Hern wishes to expand Fayetteville Steel to the property with the address number of 500, which will require crossing the county-owned lot identified as "A" adjoining Research Drive on the east and the county-owned strip of land adjoining Research Drive on the west with equipment to move steel products. That strip of land is a portion of the county-owned land with the boundary shown in blue font on **Exhibit A.** It contains 41.08 acres and is described as "wetlands" on the plat recorded in Plat Book 95-128. The common boundary of the county-owned property and Mr. O'Hern's property is described on the plat recorded in Plat Book 109-155 as a "small branch." By observation, the channel of this small branch is approximately 20' wide and 8' deep. It is a significant topographic feature on this boundary line.

To accomplish this expansion of his business, Mr. O'Hern wishes to acquire the county-owned property identified as "A" and the strip of county-owned property lying between Research Drive and his property with the address of 500. The county-owned parcel identified as "A" consists of 1.19 acres and is shown on the plat recorded in Plat Book 68-13 as "undevelopable." It does contain a sign for Cumberland Industrial Center. Mr. O'Hern has offered \$5,000 for this parcel. Mr. O'Hern is willing to purchase the other strip of land or exchange it for a strip of his property to give the county better access to the 41.08-acre tract, which is identified as Lot 5A of the Cumberland Industrial Center on the plat recorded in Plat Book 95-128. The strip of land to be exchanged would be 50' in width and run parallel to the common boundary line from a point in the boundary line that is an extension of the northeastern intersection of Assembly Court and Research Drive, which is identified as "Survey Point" on **Exhibit A**.

The county attorney presented this matter to the board in closed session May 11, 2023. The consensus of the board was to proceed with the transaction to include the exchange of the strip of land on the west side of Research Drive. Mr. O'Hern has been unable to get the necessary survey done and is still seeking a surveyor. He states that the need for expanding his business is pressing and he requests a right to use the county's properties to access his property with the address number 500, to include construction of a bridge, pipes, or culverts across the branch on the common boundary line as soon as possible.

This transaction complies with the statutory requirements for the transfer of land as an economic development activity because it enables an existing industry in the Cumberland Industrial Center to expand its business operations and enhances access to Lot 5A in the Center. The statute requires the board to conduct a public hearing on this transaction upon ten days' notice of the board's intent to convey this property. The date for the public hearing is set forth in the Resolution of Intent. At the February 8, 2024, Agenda Session, the board unanimously recommended approval of the Resolution of Intent setting the public hearing for March 4, 2024, and the grant of a temporary license to Mr. O'Hern to cross the county's property until the transaction is completed. The board approved this recommended action and adopted the Resolution of Intent at the February 19, 2024, Regular Meeting. Notice of the public hearing was published in the *Fayetteville Observer* February 23, 2024. The proof of publication will be placed on the agenda as an item of information at the next meeting after it is received to create a permanent record.

## **RECOMMENDATION / PROPOSED ACTION**

The county attorney recommends the board consider any comments received at the public hearing and approve the sale and exchange of the properties and grant a temporary license to cross the county's properties adjoining Research Drive as described in and pursuant to the terms and conditions stated in the Resolution of Intent attached hereto.

Whereas, the common border of the properties owned by Mr. O'Hern and Cumberland County is a small branch which is a significant topographic feature on this property line and limits the access to the county's property with **PIN** 0423982018; and

Whereas, the lot described as Outparcel A on the plat recorded in Plat Book 68 at page 13 is shown as "undevelopable" on the plat.

Whereas, the board of commissioners finds the following:

- (1) The market value of the lot described as Outparcel A on the plat recorded in Plat Book 68 at page 13 is \$5,000 because it is undevelopable as a single lot.
- (2) Access to the county-owned parcel with PIN 0423982018 shown as Lot 5A in Plat Book 95 at page 128 is limited by the width and depth of the channel of the branch on the common boundary line of this parcel with Mr. O'Hern's parcel with the address number 500 and PIN 0423897739.
- (3) The exchange of property described herein improves the access to the county-owned parcel shown as Lot 5A in Plat Book 95 at page 128.
- (3) No new business will be located on the parcels to be transferred to Mr. O'Hern; however, the transfer enables Fayetteville Steel to expand its business and improves access to the county-owned parcel identified as Lot 5A in Plat Book 95 at page 128.
- (4) The improved access to Lot 5A enhances the value of Lot 5A for any public purpose for which it can be used.

Therefore, be it resolved, the Cumberland County Board of Commissioners intends to sell for \$5,000 the parcel identified as Outparcel A on the plat recorded in Plat Book 95 at page 128, subject to the further terms and conditions set forth below.



- (b) The conveyance of the parcel identified as Outparcel A shall be subject to the reservation of an easement for the location, maintenance, repair, and replacement of signage for the Cumberland Industrial Center, of sufficient width to allow for these activities to occur.
- (c) Blue Skys Fayetteville Steel LLC shall be granted a temporary license to cross over the countyowned parcels adjoining Research Drive as access to Mr. O'Hern's land with address number 500 and PIN 0423897739, until such time as the transfer of these properties occurs, to include the construction of a bridge or installation of piping and culverts to cross the branch lying in the common boundary line of these properties, subject to such terms and conditions deemed necessary by the county attorney.

Be it further resolved, the clerk shall advertise notice of the board's intent to sell and exchange these properties on these terms after conducting a public hearing March 4, 2024, in accordance with G.S. 158-7.1(d).

## SUBJECT: REQUEST TO CREATE TWO PART-TIME POSITIONS TO REPLACE CONTRACTED POSITIONS IN CUMBERLAND COUNTY EMPLOYEE PHARMACY

## **BACKGROUND**

The FY 2024 budget for the Cumberland County Employee Pharmacy includes funding for two part-time contract positions – a contract Pharmacist and a contract Pharmacy Tech. These two contract positions are used to supplement the regular full-time employees who staff the Employee Pharmacy and are necessary for effective operation of the Employee Pharmacy for the County's employees and eligible retirees who use the Pharmacy.

Recent guidance from the County's Legal and Finance departments suggested that based on how these positions function, they should not be considered contract employees and instead need to be part-time County positions.

The contract Pharmacy Tech left the County effective February 2, 2024. The contract Pharmacist has also expressed their intent to leave the County before the end of the fiscal year. The timing of these departures provides an opportunity to eliminate these contract positions and create two part-time positions to replace them.

Per the Cumberland County Personnel Ordinance, new positions "may only be established by the Board of Commissioners."

Staff requests the creation of one 30-hour (.75 EE) part-time Pharmacist with benefits at a Grade 125 and the creation of one 19-hour (.475 EE) part-time Pharmacy Technician without benefits at a Grade 105 to replace the two contract employees. The Pharmacy Manager believes these positions are needed to provide the Cumberland County Employee Pharmacy with sufficient staffing to serve the County's employees.

Should this request be approved, staff anticipates the cost of these positions for the remainder of FY 2024 would be no more than \$27,654.30. This amount would allow for the posting and hiring of these positions on a

range to increase the likelihood of attracting experienced and qualified applicants.

A one-time transfer from the Wellness Fund Balance will need to be appropriated to offset the additional increase in salary expense for the current fiscal year, and going forward, the additional cost will need to be incorporated in the County's per-position contribution to the Wellness Fund along with all Fund expenses during the annual Budget process.

In addition to the creation of the new positions, a Budget Ordinance Amendment #B240978 is needed to move the necessary funds from the Wellness Fund Balance.

## **RECOMMENDATION / PROPOSED ACTION**

Staff recommends approval of the creation of two new part-time positions (a 30-hour Pharmacist and 19-hour Pharmacy Tech) to replace the existing contracted positions in the Cumberland County Employee Pharmacy and associated Budget Ordinance Amendment # B240978.
