Introduction of Mr. Greg Weber, Arts Council President/CEO

Amy Cannon, County Manager, introduced Arts Council President/CEO Greg Weber. Mr. Weber provided a brief bio of himself and shard his vision for the direction of the Arts Council under his leadership to include participation by the schools. Mr. Weber stated the Arts Council has been a leader in growing this region and he is looking forward to creating the next generation of leaders in Cumberland County through the arts.

Recognition of Retired Cumberland County Employee

Glen Heard - Sheriff's Office

Commissioner Lancaster stated Glen Heard began his career with Cumberland County as a Deputy Sheriff on September 28, 1998. Commissioner Lancaster stated the Cumberland County Sheriff's Office is a full-service law enforcement agency and over his 20-year tenure, Mr. Heard served in Operations, as a School Resource Officer in the DARE Program, at the courthouse, and in the mental health and child support facilities. Commissioner Lancaster stated Mr. Heard retired January 1, 2019. On behalf of the Board of Commissioners, Commissioner Lancaster thanked Mr. Heard for his service to the Cumberland County Sheriff's Office and the citizens of Cumberland County. # 2. PRESENTATIONS

A. Family Connects Program, a Universal Newborn Home Visiting Program by Mrs. Mary Sonnenberg, President of Partnership for Children

# BACKGROUND

The Partnership for Children of Cumberland County has partnered with Duke Family Connects to explore the opportunity of bringing the Family Connects model to Cumberland County. Family Connects is a universal newborn home visiting program which provides up to three nurse home visits to every family with a newborn beginning around three weeks of age, regardless of income or demographic risk.

The Partnership has been holding community stakeholder group meetings as a part of its feasibility work and presented the program to the Cumberland County Board of Health during the Board's April 16, 2019 meeting. The Health Department supports having this program in our community as a critical compliment to its existing Newborn Home Visiting Program and considers it to be an enhancement to the County's current continuum of services.

Ms. Mary Sonnenberg, President of the Partnership for Children of Cumberland County, will present the Family Connects program and model to the Board of Commissioners.

RECOMMENDATION / PROPOSED ACTION No action requested; for presentation purposes only.

Duane Holder, Assistant County Manager/Interim Health Director, introduced Mary Sonnenberg, President of the Partnership for Children of Cumberland County. Mr. Holder reviewed the background information recorded above and stated the Family Connects Program is an innovative and evidence-based model and the Health Department supports having this program in the Cumberland County community.

Ms. Sonnenberg introduced Sharon Moyers, PFC Community Engagement Administrator, and Megan Squires, Family Connects International Implementation Specialist. Ms. Sonnenberg stated the newborn home visiting program provides up to three nurse home visits to every family with a newborn beginning around three weeks of age and offers supportive guidance to families in several areas. Ms. Sonnenberg stated the cost is estimated to be \$3 million per year which will come from a variety of resources so everyone has to come to the table to make this program happen.

Ms. Sonnenberg shared a video of a CBS News clip that provided a broad perspective of the Family Connects Program. Ms. Sonnenberg stated this program focuses on the prevention of child abuse from prenatal care to birth and to five years of age and helps new parents connect with their infant by providing them with the confidence and support needed to sustain infant and parent health, child development and overall family well-being.

Ms. Squires briefly touched on components needed to replicate the model, how the program was launched in other communities and some of the outcomes realized by those communities. Questions followed.

# PROCLAMATION

WHEREAS, the Purple Heart medal, an American decoration that is awarded in the name of the President of the United States, is the oldest military decoration in the world in present use; and

WHEREAS, the Purple Heart was established by General George Washington at Newburgh, New York, on August 7, 1782, during the Revolutionary War, as an incentive to the Continental Army; and

WHEREAS, the Purple Heart is awarded directly or posthumously to members of the Armed Forces who are wounded, or die from wounds received, in armed conflict with an enemy force or while held by an enemy force as a prisoner of war, or are wounded or killed as a result of friendly fire, or as otherwise designated by the President of the United States; and

WHEREAS, the Purple Heart may also be awarded to a civil or foreign service employee from a U. S. Government Agency or Department attached to a military unit performing intelligence, counter-terrorist, or other duties, with the military unit wounded by international terrorists; and

WHEREAS, a new design of the Purple Heart medal was issued on February 22, 1932; and

WHEREAS, the recipients of the Purple Heart have known the meaning of sacrifice in the preservation of the United States of America and the preservation of national interests at home and abroad; and

WHEREAS, the sacrifices made on our behalf will forever be an inspiration to all citizens of Cumberland County, North Carolina; and

WHEREAS, Cumberland County, North Carolina was proclaimed a Purple Heart County on August 7, 2012 and pledges its ongoing commitment to and support for the men and women who so honorably serve our nation.

NOW, THEREFORE, BE IT PROCLAIMED, that the Cumberland County Board of Commissioners hereby salutes the valiant men and women who are recipients of the Purple Heart and recognizes the support and sacrifice of their loved ones.

C. Approval of Resolution Supporting the Ozone Advance Program

#### BACKGROUND

The Fayetteville Area Metropolitan Planning Organization (FAMPO) Air Quality Stakeholders is requesting a resolution seeking continued support of the existing Ozone Advance Action Program. This program is a collaborative effort among local governments, agencies and other groups interested in protecting and improving the air quality of Fayetteville and Cumberland County. Attached is a proposed resolution and a copy of the most recent Ozone Advance Program. The resolution will be part of a package sent to the Environmental Protection Agency demonstrating local support for efforts to protect air quality.

RECOMMENDATION / PROPOSED ACTION Consideration of approval of the proposed resolution.

# RESOLUTION SUPPORTING THE OZONE ADVANCE PROGRAM

WHEREAS, the federal Clean Air Act, through the Environmental Protection Agency (EPA), establishes air quality standards to protect public health and welfare; and

WHEREAS, Cumberland County has acknowledged the importance of these standards in promoting quality of life, future economic development, and healthy communities; and

WHEREAS, for the benefit of our region, Cumberland County commits to maintain at or below the Federal ozone standard as set annually by the EPA; and

WHEREAS, in 2003, the Cumberland County Board of Commissioners and partner municipalities participated in the EPA's Early Action Compact and created a committee focused on air quality to proactively improve air quality for our citizens; and

WHEREAS, the EPA, in conjunction with state governments, business, industry, and environmental interest, has developed an option known as an "Ozone Advance Program" through which an area, in partnership with the North Carolina Department of Environmental and Natural Resources and the EPA, can voluntarily improve conditions through strategies developed through an Action Plan to help avoid a designation of non-attainment; and

WHEREAS, the benefits of participating in an Ozone Advance Program include clean air sooner, potentially avoiding non-attainment designation, preference during the EPA federal grant allocations, flexibility to achieve standards in cost effective ways, development of local standards in partnership with stakeholders and the state, and other benefits.

NOW, THEREFORE, BE IT RESOLVED, that We, the Cumberland County Board of Commissioners, fully supports the Ozone Advance Program as approved by the Fayetteville Area Metropolitan Planning Organization Transportation Policy Board and resolves to maintain attainment and work to improve air quality as a partner.

# E. Approval to Pay Prior Year Invoices

# BACKGROUND

The Sheriff's Office is requesting to pay a Fiscal Year 2018 invoice to Point Security, Inc. in the amount of \$635.22. This invoice was received on May 15, 2019 after the deadline to pay Fiscal Year 2018 invoices. Staff has verified that this invoice has not been paid and is in fact due. Sufficient funds are available in the current year budget to absorb this expenditure.

F. Approval of Settlement in Centerplate Litigation

# BACKGROUND

Centerplate filed suit against Spectra Management, Spectra Food Services, Cumberland County Civic Center Commission, Cumberland County Board of Commissioners, and County of Cumberland, seeking monetary damages and a declaration that the award of the Food and Beverage Service contract at the Crown Complex to Spectra Foods was invalid and that Centerplate be declared to be the proper food and beverage vendor. Subject to formal approval of the Board of Commissioners, the County Defendants have reached settlement with Centerplate in which the County will pay \$25,000 in exchange for a release of all claims and the filing of a voluntary dismissal with prejudice as to the County Defendants. An appropriate representative of Centerplate has signed the Settlement Agreement and Release.

County Attorney has recommended this settlement to avoid further litigation costs and potential depositions of current and former commissioners and current and former members of the Civic Center Commission.

## RECOMMENDATION / PROPOSED ACTION

In the closed session of the May 6, 2019, meeting of the Board of Commissioners, the Board indicated its consent to place approval of the settlement on an appropriate consent agenda as follows:

Approve settlement in 18 CVS 194, Volume Services, Inc. and Service America Corporation, collectively d/b/a Centerplate v. Ovations Food Services, L.P. d/b/a Spectra Food Services and Hospitality, Global Spectrum, L.P. d/b/a Spectra Venue Management, Cumberland County Civic Center Commission, Cumberland County Board of Commissioners, and County of Cumberland, for \$25,000 from County with Centerplate releasing all claims against the County Defendants and filing a dismissal of the lawsuit as to the County Defendants
